ACTION ALERT!

SB 250 Needs Assessment Amendments (Sen. Anderegg) just introduced late Friday, is written for the Promontory Point Resources solid waste landfill and is intended to work around a problematic needs assessment requirement that is in the way of PPR obtaining a permit to operate as a Class I and V hazardous waste landfill. This would allow PPR to bring in coal ash and other out-of-state hazardous wastes that could prove a serious threat to the health of Great Salt Lake. We will have to rally all our resources to oppose this bill! It will be heard in Senate Business & Labor Committee Monday at 2, so call and email committee members now!

Utah Rivers Council is urging opposition to HB 328, which would study diverting Green River water to the Wasatch Front https://mailchi.mp/utahrivers/will-green-river-diversion-advance-bear-river-development. Join URC and other allies like Great Basin Water Network and Utah Sierra Club in opposing this bill.

News of Week Six (Week # 6)

HB 233, the Depleted Uranium-funded Natural Resources Legacy Fund, was defeated in Senate NRAE but will be brought back to that committee under reconsideration rules on Monday at 8 AM.

The latest version of HB 328, requires the Division of Water Resources to update a 2002 study of diverting Green River water to the Wasatch Front, but there is no longer any funding for that work.

Inland Port Bills: HB 347 (Rep. Gibson) was amended to offer a minor sop to environmental concerns before passing the House. It will be passed in the Senate the last week under suspension of the rules. SB 112 (Sen. Escamilla) was rewritten to allow the UIPA to spend money on nearby community improvements before passing the Senate.

Bills dealing with climate change are getting no love – not even hearings – in a Legislature stuck in full denial. Meanwhile, mining and oil and gas bills and budgets flourish.

Budget News

The Executive Appropriations Committee finalized their "Funding Options List" Friday. Among the highlights for conservation: \$2 m. for the LeRay McAllister land conservation fund; \$450,000 one-time for Dalton Wells trails, improvements and project engineering; \$2 m. for

Water Restoration projects benefitting wildlife and live-stock; \$115,000 on-going for stewardship of historic and prehistoric cultural resources; \$5 m. for electric vehicle research and recharging infrastructure projects; a \$2 million increase for invasive species mitigation work and \$1.4 m. for watercraft inspection stations to mitigate quagga mussels; \$10 m. for drinking water plans and projects; \$200,000 for Uintah Basin ozone research; \$2.25 m. total for wildfire preparedness, forest fire treatment and mitigation; and \$200,000 for wildlife management research.

The general and supplemental appropriations bills will be passed Tuesday. To complete budget actions, legislators must prioritize all bills with fiscal notes (with budget costs or revenues) before adjourning Tuesday and pass all bills with fiscal notes of \$10,000 or more by adjournment Wednesday. The final budget action on the "bill of bills" will be completed Thursday.

What's Ahead

Standing Committees meet Monday for the final times from 8-12 and 2-4. Both chambers will be on the floor all the time Tuesday through sine die on Thursday 12 AM. Caucuses will meet each day. Still no word on if and when the House will "wiping the board" to prioritize bills for debate and action. Here are the calendars for the 7th and final week:
